

- "...discussion of route options is based on getting the trucks from the Quarry to the nearest truck route, but does not consider the impact along the full length of the haul routes."
- "The evaluation does not include typical criteria" such as, but not limited to:
  - Noise impact on adjacent land uses;
  - Operational or Safety related concerns on the road sections along the routes; and
  - Potential impact or Conflicts with other road users."

  - 170 Acre Crater up to 38 Meters Deep,
  - a peak of 1140 Truck Trips per day,
  - up to 3.6 Million Gallons of Water per day,
  - 25 to 30 Year Lifespan
- + 150 Acres not in the Applications
- 8<sup>th</sup> Largest Quarry Operation in Canada


